

**Preliminary running order:** The run order has been chosen as: Medium, then Small, then Large. This is the running order for all classes in the Fun Test.

Note that Order may be adjusted based on the actual number of entries submitted. The final class order will be published in the final confirmation email. Dogs being handled by the same person must be separated into different staged groups. Bitches in season will run at the end of the class with panties securely on, as per BHA rules.

**Withdrawals:** Withdrawals after the closing date due to injury of the dog will be eligible for a 75% refund of entry fees paid upon receipt of a note from your veterinarian. The note must be dated and emailed, mailed, or handed to the Trial Secretary **prior to the close of the event.** Priority mail is not necessary. If you have questions, contact the Secretary directly at bh@duderanchpetresort.com.

**Administrative Reminders:** If you provide your email address, we will acknowledge receipt of your entry via email within a few days. If you do not receive an initial confirmation within one week of mailing your entry, contact the Secretary. **Any errors must be reported no later than the move-up deadline.** If you do not have email but want us to confirm receipt of your entry, please include a SASE with your entry and we will confirm your entry when we email the final confirmation. Please double-check your entry form and remember to **sign the Release Form.**

**A \$35.00 service charge will be added for any returned checks.**

### **Exhibitor Information:**

- All dogs must be on a maximum 6' leash, except while hunting, and be under control while on the grounds. Flexi-leads may not be used within 50 feet of the ring.
- Any dog that fouls the ring in any way (e.g., urinates, defecates, vomits) will be immediately excused, as per BHA rules. The handler is expected to clean up after the dog, both in the ring and out.
- All entries must be accompanied by entry fees and be **postmarked** prior to the day/time of closing to be considered valid. Late entries must be **received** by the closing late fee date or will need to be entered as DOS.
- Exhibitors not attending the General/Judge's briefings will still be held responsible for knowing the information given in these briefings.
- All dogs must be crated or on a leash at all times except when running. Dogs may be crated in the car, in a tent, or out on the grounds. Barking dogs **MUST** be crated in an enclosed car so that they do not disturb the neighbors. Please ensure your crate is secure as the dogs may be highly excited.
- No unattended vehicle may be left running while unattended. Doing so presents an unacceptable risk of starting a fire. Any competitor caught violating this rule will be asked to leave the property with no refund provided.
- **At no time should dogs be tied out or otherwise left attached to something other than a human; specifically, leaving your dog(s) tied to an unattended chair or in an open crate is not safe in a trial environment and, therefore, not allowed.**
- Any dog that is sick, injured or lame will be excused from the trial grounds.
- The schedule is fluid throughout each day. No special considerations will be made to accommodate activities outside of the trial, distance/trip home, etc..

- Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of a refund if the event committee deems the exhibitor to be in violation of this requirement, per BHA regulations.
- Handicapped parking is available, but the blinds and rings are not easily wheelchair accessible due to uneven natural grounds. Please indicate on your entry form if you require Handicapped parking. State indicia required.

**Bitches in season** are eligible to compete but will be required to be kept separate from all other dogs and run in panties/britches at the end of their class, regardless of height. Entry fees for bitches that come into season may be withdrawn and would then be eligible for a refund until date/time of closing of the trial. Additionally, if the handler chooses to pull after the closing date, the bitch in season can be treated as an injured dog and receive a 75% refund after a veterinarian note is received. ***If bringing a bitch in season, please inform the Trial Secretary prior to the trial. You must also make sure the Judge informs all exhibitors at the briefing.***

**Aggressive/Disruptive Dogs: Please keep dog barking and other disruptions to a minimum for the comfort/safety of all participants.** Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial, if justification is found to do so by the judge and/or event committee. In that case, no refund of any fees paid will be made. Exhibitors are expected to know the BHA rules as far as aggression is concerned, both on and off the course.

**Collars and Leashes:** Per BHA rules, electronic collars/devices are not allowed anywhere on the site – this includes electronic bark collars as well as citronella collars. Head halters are also not allowed at BH trials. Prong collars may be used on the site while walking dogs, but are not allowed while the dog is competing. Dogs may not be brought to the gate in a prong collar or on a Flexi-lead. Dogs **MUST** run “naked,” without a collar/harness; owners **MUST REMAINED DRESSED**. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced. All dogs must be on leash at all times except when in the ring.

*Exercise your dog responsibly. Please pick up after your dog at the show site. Cleanup equipment and designated trash bags & receptacles are provided. All dogs must be on leash except when in the ring hunting at the trial site.*

## AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog participate and/or judged, I (we) agree to hold Barn Hunt Association (“BHA”), the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary, the Dude Ranch Pet Resort® and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event as well as any employees or volunteers of the aforementioned parties, and any BHA approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to or loss of property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death, disappearance, theft, loss or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.

I acknowledge that the event site has active photography and audio recording systems in place, and I consent to photography, audio recording, video recording and its/their release, publication, exhibition, or reproduction to be used for news, web casts, promotional purposes, telecasts, advertising, inclusion on web sites, or any other purpose by the Dude Ranch or its assigns. Further, I release the Dude Ranch, its officers and employees, (i.e. each and all persons involved) from any liability connected with the taking, recording, digitizing, or publication of photographs, computer images, video and/or or sound recordings.

This Agreement bind the parties for the current event hereat, and all subsequent classes/training/events in which they hereafter participate hereat.

I (we) agree to abide by the rules of BHA currently in effect at the time of the event date. I/we attest that the dog entered is healthy and vaccinated or tittered (presenting safe levels) in accordance with the laws of the Commonwealth of Virginia. 
